7. Description of the contract

The disaster that struck B-H in May 2014 affected a quarter of its territory and approximately one million people. Despite the intervention's impressive outreach across 53 local governments in B-H, with more than 610,000 people assisted, there remains a significant number of the most vulnerable yet to recover. The overall objective of this Project is sustainable recovery of flood and landslide affected communities in the entity of Federation of Bosnia and Herzegovina, advanced through improved living conditions for vulnerable households whose homes were substantially damaged or destroyed in the disaster and restored economic and livelihood opportunities for low-income vulnerable households assisted with housing recovery.

Purpose of the contract is construction of three new housing units (two of them - type 1 and one - type 2) in Zavidovići Municipality and rehabilitation works on two damaged homes/housing units in Žepče Municipality, as approved within provisions of Amendment 2 to the Project Cooperation Agreement between the United Nations Development Programme (UNDP) and Arbeiter-Samariter-Bund Deutschland e.V. (ASB) and in line with the EU approved Notification regarding the changes introduced to the Annex III to the Grant Agreement Contract no 2017/388-195 between European Union, represented by the European Commission and United Nations Development Programme (UNDP).

8. Provisional commencement date of the contract

October, 2020

9. Period of implementation of tasks

2 (two) calendar months, until the issuance of provisional acceptance certificate.

TERMS OF PARTICIPATION

10. Eligibility and rules of origin

Participation in this tender procedure is open only to the invited tenderers.

Participation is open to all legal persons participating either individually or in a grouping (consortium) of tenderers which are established in a Member State of the European Union or in a country or territory of the regions covered and/or authorised by the specific instruments applicable to the programme under which the contract is financed (see heading 17 below). All goods supplied under this contract must originate in one or more of these countries.

11. Subcontracting

Subcontracting is allowed. The upper limit authorised for subcontracting is 30% of the value of the tender.

Subcontractors, suppliers and entities upon whose capacity the tenderer relies for the selection criteria must be eligible in respect of the rules on nationality and origin for the financing programme detailed in Section 10 above.

12. Grounds for exclusion

Natural persons, companies or undertakings falling into a situation set out in section 2.3.3.1 ('exclusion from participation in procurement procedures') and section 2.3.3.2 ('rejection from a given procedure') of the Practical Guide, are not entitled to participate in this tender procedure or be awarded a contract. Should they do so, their tender will be considered unsuitable or irregular respectively. Tenderers must provide declarations to the effect that they are not in any of the exclusion situations listed in section 2.3.3 of the Practical Guide. The declarations must cover all the members of a joint venture/consortium. Tenderers guilty of making false declarations may also incur financial penalties and exclusion in accordance with section 2.3.4 of the Practical Guide.

Those exclusion situations apply to all members of a joint venture/consortium, all subcontractors and all suppliers to tenderers, as well as to all entities upon whose capacity the tenderer relies for the selection criteria.

13. Number of tenders

Tenderers may submit only one tender. Tenders for parts of the works will not be considered. Tenderers may not submit a tender for a variant solution in addition to their tender for the works required in the tender dossier

In order to be eligible for the award of the contract, tenderers must provide evidence that they meet the selection criteria. If a tender is submitted by a consortium, unless specified, the selection criteria will be applied to the consortium as a whole.

The selection criteria for each tenderer are as follows:

14.a Economic and financial capacity of candidate:

- the total cumulative turnover in construction works in the last 3 (three) years must be at least BAM 500,000.00 (five hundred thousand BAM);
- the tenderer must have access to sufficient credit and other financial facilities to cover the required cash flow for duration of the contract. In any case, the amount of credit available must be at least BAM 50,000.00 (fifty thousand BAM).

14.b Technical and professional capacity of candidate:

- the tenderer must be a registered firm capable to carry out the specified works. It must be duly authorized / licensed to perform the works under this contract in accordance with the relevant law in force in B-H. Activity code AC BiH 2010: 41.20 must be submitted with the tender (*Classification of the legal entity in accordance with the activity classification*);
- the tenderer shall present its experience in implementation, as a prime contractor, of at least 1 (one) project of the similar complexity and nature as the works concerned by the tender over the last 8 (eight) years prior to the tender submission deadline. The Contracting Authority reserves the right to ask for copies of certificates of final acceptance signed by the supervisors/contracting authority of the projects concerned.

15. Award criteria

The sole award criterion will be the price: the most economically advantageous tender is the technically compliant tender with the lowest price.

TENDERING

16. Ethics clauses

The tenderers are subject to the Ethics clauses, detailed in Section 2.4.14 of the Practical Guide.

17. Legal basis¹
