In order to improve and upgrade conditions of these Safe houses, ASB SEE, Main Office in Bosnia and Herzegovina intends to launch a tender for rehabilitation/reconstruction works on above mentioned houses with companies in Bosnia and Herzegovina.

The provisional launch of tender is April 22, 2024.
